SECTION 5: FIREFIGHTING MEASURES

5.1 Extinguishing media:

Product is non-flammable under normal conditions of storage, manipulation and use, but the product contains flammable substances. 7.1 Precautions for safe handling:

A.- Precautions for safe manipulation
